Trial Regulations

Proof of current rabies vaccinations must be furnished upon request. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable disease and have appropriate vaccinations.

All dogs must be held on leash, except during trial. Dogs must be kept a suitable distance away from the trial area. Handlers should bring water and shade and pick up after their dogs.

This Show will be open from 9 AM until 1 hour after awards are completed. Consult judging program for time of judging.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.

Dogs not required for further judging will be excused.

Entry fee shall not be refunded in the event that the dog is absent, excused by the judge or veterinarian, or barred from competition by action of the Show Committee.

Site Information
