#### **Trial Regulations**

- Proof of current rabies vaccination must be furnished on request. Expulsion from the grounds may ensue if such proof is not furnished upon request.
- Bitches in season shall be eligible and will run in catalog order as listed in the class in Trials.
- All dogs must be kept on leash, except during trials. Dogs must be kept a suitable distance away from the trial area. Handlers should bring water and provide shade for their dogs. Handlers are required to pick up after their dogs.

#### Move-ups

• A dog may be moved up in the next test or trial, provided that the next level class is available (i.e.: offered in the premium list) and that a Judge is available, and, provided further, that the class is not filled. Notification must be made to the Herding Secretary at least one-half hour before the start of the event.
