Pre-Entries Close(postmark): Entries close June 30. Entries postmarked after closing date will be taken at Day of rate. Day of trial entries will be taken if the trial is not full.

All entries must have a postmark. NO hand delivered entries accepted. Entries must be made on the official ASCA entry form.

Dogs may be substituted if owned by the same person.

COVID-19 INFORMATION

- You were exposed to COVID-19 within the 14 days preceding the trial and do not have confirmed negative result from testing done after the exposure.
- You have COVID-19 or any of its symptoms at the time of the trial, or feel ill in any way during the trial.

GENERAL INFORMATION

The trial will be run and judged under ASCA rules as published in the most current rulebook. Run order will be drawn in advance. Bitches in season will run in order. All non-ASCA registered dogs must have an ASCA tracking number to receive ASCA titles. See https://www.asca.org/orcall (979) 778-1082

Run Order will be drawn before trial. Bitches in Season will run in order.

Dogs must be confined or on leash at all times when not working or in a designated exercise area. Individuals are responsible for any damage done to stock and/or facilities. Dogs that attack or maul any person, dog or livestock will be disqualified.

RUNNING ORDER OF TRIALS

We will be starting at Flying Bucket first and after handlers meeting will run Trial 1 Cattle, when that is done we will then run Trial 2 Cattle.

When the first judge is done he will go the Cherry Hill and have a handlers meeting there about 15 minutes after he arrives. After Handlers Meeting will begin judging Trial 1 ducks and then moving on to Trial 1 sheep.

When the second judge arrives at Cherry Hill we will break for our final handlers meeting (for those coming from cattle) and then second judge will start judging Trial 2 sheep and finishing up judging Trial 2 ducks.

Both days will run in this order.

STOCK REPLACEMENT FEES: \$35 per duck, \$300 per sheep and Market Value on cattle. Owner of dog will be responsible for any veterinary expense to the stock.

FOOD: Plan to bring your own water and food.

Many may encounter a ROAD CLOSING within a mile from Flying Bucket ... if your gps takes you down BLANK RD – that road is now CLOSED! See below for other routes.

<u>DIRECTIONS FOR 6952</u> Harder Road Hemlock, NY – There will be herding signs out front. ** Blank Road is closed and no access to Anya's Farm from there. ** Follow the directions below to avoid the Road Closure**

NYS Thruway Exit 46 (for I-390 South) from the north, east or west - Keep right for I-390 South (Corning) 11 miles Exit 10 for Avon/Lima. Turn left onto NY-5/US 20 east. 3 miles turn right onto Livonia Center Road. In 5 miles turn left onto Federal Road. In 4 miles turn left onto Harder Road. Flying Bucket Farm ½ mile on left.

Coming from the South – **I-86 to I-390 North**. About 16 miles take exit for NY 15 / Rte 21. ½ mile turn Right onto NY 15N. About 15 miles turn Right onto Federal Rd. 3.5 miles turn Right onto Harder Road. Flying Bucket Farm ½ mile on left.

DIRECTIONS FOR 7393 Corby Rd Honeoye Falls, NY

NYS Thruway Exit 46 (for I-390 South) from the north, east or west

Follow 390 S to the Rush Exit Turn left onto 15 South to the intersection of 251. Turn left to 251 east. Then turn right at stop light onto 15A south. Follow 15A south to Corby Rd and then turn left. Farm will be on your left.

<u>Coming from the South</u> - *I-86 to I-390 North* Follow I-390 North to Avon Exit – Exit 10. Turn right onto 20 E and then turn left onto Heath Markham Rd. Cross over 15A onto Corby Rd. Farm will be on the left in .3 of a mile

DIRECTIONS FOR Flying Bucket to Cherry Hill – 12 miles

Turn right out of Flying Bucket Farm on to Harder Rd for .8 mile. Turn right onto Federal Rd for 3.5 miles, then Turn right onto US 20A East for 1.5 miles, Turn left onto NY 15A North for 7.9 miles, then turn right onto Corby Rd farm will be on your left in .3 mile. Follow signs for parking.

Housekeeping:

- Garbage cans are available for trash and dog waste
- Please clean up after your dog
- All gates must be kept closed if they were closed when you came through
- Please keep dogs on leash while on the trial site
- Please adhere to the off limits rules
- Bring your own chairs and canopies- there is NO shade at Flying Bucket Farm and limited shade at Cherry Hill Training Center
- Smoking in vehicles only
- Park in designated areas only
