Sheep & Ducks – Four Point O Farm, 86 Winnicutt Rd, Stratham, NH 03885

Start Time: Cattle – Handler’s Meeting 8am – Cattle Only

Runs will begin at end of handler’s meeting

Sheep & Duck handler’s meeting will start in Stratham approx. one hour after  
cattle runs are finished in Brentwood

Courses: Saturday – ASCA Course E (Left Hand Chute) for all livestock

Sunday – ASCA Course B for all livestock

Livestock: Cattle – 3 Head of Dexter or Dexter Crosses

(9-12 runs/day) \$70/run

Sheep – 3-5 Head of Katahdin

(15-25 runs/day) \$60/run

Ducks – 5 Head of Calls or Appleyards

(15-25 runs/day) \$50/run

Pre-entries will be accepted with the post mark dates between:

May 6<sup>th</sup> and June 3<sup>rd</sup> , 2025

Entries accepted after June 3<sup>rd</sup> will increase by \$10/run

PayPal is now available as a form of payment for ASCNE entries. Please read below for instructions on how to use this:

*Payment can be made by sending in a check with your entries to the trial secretary listed on the Premium or via PayPal at [ascnetreasurer1973@gmail.com](mailto:ascnetreasurer1973@gmail.com) (please **DO NOT** send as "Friends and Family"). Please include an additional 3% with any PayPal payments along with the owner / exhibitor's name and the show AND venue you are entering. A separate transaction must be made if you are entering multiple venues (ex: 1 transaction for conformation, 1 transaction for agility, etc). Entries are not valid until full payment is made, including the additional 3%. Day of show entries must be paid by either check or cash.*

Entries will be accepted in post mark order. In case of a duplicate postmark entry, a random draw will be held for those entries, for each specific livestock, to determine order of acceptance. Day of show entries will be allowed if space is available. A waiting list will be established if the trial fills. After the close of entries, entry fees will only be refunded if your spot can be filled from the waiting list.

Run Order will be drawn prior to the trial day.

All trials will be run according to the ASCA Stockdog Rules which can be reviewed at ASCA.ORG  
Bitches in heat will run in order and must be crated at all other times.

Injured livestock expense is the financial responsibility of the dog's owner/handler.

Replacement costs for livestock are as follows:

Cattle \$1200, Sheep \$500, Duck \$50

Awards will be presented for 1<sup>st</sup> – 4<sup>th</sup> placements in each class of livestock in each division.

HIT Australian Shepherd and HIT Other Breed will be awarded each day.

High Combined Started Dog for the Weekend will be awarded to the Started level dog with **the two** highest combined Started Qualifying scores from Saturday and Sunday

Qualifying ribbons and Title Ribbons will also be available.
